

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.lancasterlawfirm.com](http://www.lancasterlawfirm.com), and Lancaster Law Firm and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Lancaster Law Firm include [www.lancasterlawfirm.com](http://www.lancasterlawfirm.com) and LLF. The LLF website is a Blog, Information, Education, List of Services offered site. By using the LLF website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, LLF may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

LLF may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through LLF's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Use of your Personal Information**

LLF collects and uses your personal information to operate and deliver the services you have requested.

LLF may also use your personally identifiable information to inform you of other products or services available from LLF and its affiliates.

### **Sharing Information with Third Parties**

LLF does not sell, rent or lease its customer lists to third parties.

LLF may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to LLF, and they are required to maintain the confidentiality of your information.

LLF may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on LLF or the site; (b) protect and defend the rights or property of LLF; and/or (c) act under exigent circumstances to protect the personal safety of users of LLF, or the public.

### **Tracking User Behavior**

LLF may keep track of the websites and pages our users visit within LLF, in order to determine what LLF services are the most popular. ### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by LLF. ### **Use of Cookies**
